8. CITY OF POINTE-CLAIRE BY-LAW #2642 SPECIFIES THAT:

- Art. 8:** The license shall not be transferable.
- Art. 9:** The holder of the issued license, its agents or representatives shall be authorized to carry on its activities during the days for which this license has been issued.
- A. From 9: 00 a.m. to 4:00 p.m. from Monday to Friday
 - B. From 1:00 p.m. to 5:00 p.m. on Saturday and Sunday
- Art. 10:** The holder of the issued license , its agents or representatives shall:
- A. Carry on their activities without in any way troubling the peace and tranquility of the citizens.
 - B. Carry a copy of the said license and identity card with photography at all times.
 - C. Be under the obligation to show up the issued license and its identity card to anybody who requests so.
- Art. 11 & 12:** It is prohibited for any peddler to knock on the door or to ring the doorbell of any residence displaying a **sticker** in a visible manner on the mail box or on the main door of the residence indicating that he/she wishes that no peddler calls on to its residence,
