It is also understood and agreed that no specific location is reserved for this boat and that the City of Pointe-Claire may move the boat at any time for any reason whatsoever, and, while moving it, the City of Pointe-Claire, its employees, members and representatives will act as my agent and representative, and this move will be my sole responsibility. It is understood that no work is permitted on the boat during the rental period with the City of Pointe-Claire. This contract is non-transferable and it is strictly forbidden to sublet a rental space. Payment of the fee is due at the signing of the contract. The City of Pointe-Claire also reserves the right to cancel this contract, without refund, and assign the place to another contracting person if not occupied by June 30, 2017. The City of Pointe-Claire reserves the right to temporarily assign a rentable space when contracting people are absent.
