WHEREAS the City of Pointe Claire will coordinate the work on intersections under the responsibility of NouvRL (REM), which will be integrated into the current project in accordance with the technical specifications.

WHEREAS the new control units to be installed are "Intelight (CONTROLLER XN-1)" as mentioned in the technical specifications approved by all parties involved. These control units will be acquired by the STM from the City of Montreal.

WHEREAS the new 16-relay control units to be installed are NEMA TS2-compliant models, as described in the technical specifications. They will be supplied by the contractor carrying out the work.

WHEREAS at the end of the work, the equipment will be bequeathed to the linked cities affected by the work. The associated cities will retain responsibility for the traffic lights on their territory, as is currently the case. As with all current equipment, they will be responsible for maintaining and/or repairing it as necessary (in the event of an accident, for example). It should be noted that training will be organized to enable the maintenance teams of the linked cities to carry out the necessary repairs and maintenance. For all bus preferential measures work at traffic lights, provisional and final acceptance of the work will be carried out jointly with the technical services of the linked cities, and the contractor's warranties will be transferred to them.

WHEREAS since the project is subsidized by the MTQ, the equipment and programming must be maintained in operation by the associated cities for a minimum period of 10 years, starting on the date of installation. The traffic lights will be programmed to maximize traffic flow, especially for public transit.

WHEREAS the proposed project consists in transforming the single-family home to allow the operation, in the front part of the building (210.4 m2 / 2264.8 sq. ft.), of a tearoom with a capacity of 40 people and an apartment (58.6 m2 / 630.8 sq. ft.). The latter would be completely separate from the tearoom, with a separate entrance door located in the rear part of the first floor.

WHEREAS the number of parking spaces available on the site is insufficient to meet the needs of the proposed mixed use.

WHEREAS Council considers that the excessive capacity of the Tearoom combined with the absence of a sufficient number of compliant parking spaces on the site to satisfy the need for the use makes the project incompatible with the characteristics of the zone.
