- The omission to produce a list of the subcontracted work, as required by paragraph g) of clause 0.01.09 of the "instructions", as well as the form number 16 that must accompany it;
- The addendum number 1 was not signed and incorporated into the "Robert Lapointe Transport Inc." bid, although addendum 2 was, as it has been recognized, in jurisprudence, that addendums are important documents that must be clearly recognized as an integral part of the contract by bidders;
- The price list (annex 2 of the tender), as produced by "Robert Lapointe Transport Inc." was not signed, although it is an important document;

TO consequently award the contract for the reconstruction of Donegani Avenue, between Coolbreeze and Valois Bay Avenues, including the addition of a cycle path and the repair of Roundtree Crescent Avenue to "Construction Bauval Inc.", who provided the lowest conforming bid for a total amount of \$3 187 656.01, taxes included, in conformity with tender documents GP170023;

TO charge this expense to Budget Accounts 22-417-02-860, 22-417-12-860 and 22-410-22-765, as indicated in Certificate No. 17-10089 issued by the Treasurer on June 22, 2017.
