PUBLIC CONSULTATION

Fighting racial and social profiling

The <u>Commission sur le développement social et la diversité montréalaise</u> and the <u>Commission sur la sécurité publique</u> invite citizens to take part in a joint public consultation on the fight against racial and social profiling. This consultation will make it possible to report on actions already taken by the city and to identify future measures to be considered in order to eliminate racial and social profiling, as well as the contribution of each citizen in achieving this common goal.
