

MINUTES OF THE REGULAR MEETING OF THE COUNCIL OF THE CITY OF POINTE-CLAIRE, HELD AT CITY HALL, 451 SAINT-JEAN BOULEVARD, POINTE-CLAIRE, QUEBEC, **ON MAY 1, 2018,** AT 7:30 P.M., AFTER DUE NOTICE WAS TRANSMITTED ON FRIDAY APRIL 27, 2018.

ADOPTION – DECLARATION FOR THE PROTECTION OF CANADA MONARCH BUTTERFLY

WHEREAS the monarch butterfly, with its bright colors of orange, white and black, is emblematic of North America;

WHEREAS the monarch butterfly with all pollinators, plays a vital role in North America's biodiversity and diet;

WHEREAS monarch butterfly colonies migrate annually from their Mexico and California wintering site to Canada in the spring;

WHEREAS monarch butterfly habitats in Canada, including wastelands, fields and gardens offering milkweed plants to the monarch caterpillars, are declining;

WHEREAS monarch populations would have decreased by 83% from 1994 to 2015;

WHEREAS the Committee on the Status of Endangered Wildlife in Canada (CSEWC) has classified the monarch in the category of endangered species in 2016 and that the Government of Canada has classified the monarch in the category of species of special concern under Appendix 1 of the Species at Risk Act;

WHEREAS the municipalities play a crucial role for the recovery of the monarch butterfly populations, by creating breeding habitats, by adopting favorable regulations for monarch butterflies and by inviting the population to develop gardens with milkweed;

WHEREAS the City of Pointe-Claire wishes to offer to the monarch butterfly colonies a healthy breeding habitat and a place to welcome these colonies and that Pointe-Claire has develop an educational garden for the monarchs, organized an event related to the monarch butterfly and modify the regulations to favor native gardens and reduce the use of pesticides.
