purchase order;

RESOLVED: TO award a contract for the leasing of six (6) KIA SOUL EV, year 2018, for

a period of 48 months to KIA DORVAL PREMIUM (230 avenue Michel Jasmin, Dorval, QC, H9P 2N5), who provided the lowest conforming bid, for a total amount of 152 930,88\$, taxes included, in conformity with tender

documents TP180041.

To charge this expense to Budget Accounts 03-920-17-003 (\$ 145 843.47)

and 03-920-18-003 (7 087.41). The whole as indicated on Certificate No.

18-11712 issued by the Treasurer on July 13th, 2018.

To indicate the City reserves the option to buy the six (6) vehicles at the end of the 48 months for a total amount of \$73 361.40, taxes included.
