APPEAL - DECISION RENDERED BY THE BY THE DEMOLITION COMMITTEE ON MARCH 21, 2019 AS TO APPROVE THE PROGRAMME FOR REUTILISATION OF THE VACATED LAND FOR THE IMMOVABLE LOCATED AT 286 BORD-DU-LAC-LAKESHORE ROAD

WHEREAS on August 9th, 2018, in accordance with the criteria, rules and procedures set out in the Demolition By-law number PC-2818 and in the law, the Demolition Committee rendered a decision authorizing the demolition of the building located at 286 Bord-du-Lac-Lakeshore Road and refusing the programme for the reutilization of the vacated land;

WHEREAS on September 26th, 2018, Municipal Council, sitting in appeal of the decision of August 9th, 2018, confirmed the decision of the Demolition Committee regarding the authorization of demolition and the refusal of the programme for the reutilization of the vacated land;

WHEREAS the decision of September 26th, 2018 indicated that the authorization to demolish would not be effective unless a programme for the reutilization of the vacated land be submitted to the Demolition Committee in the six (6) months following this decision and be subsequently approved;

WHEREAS a programme for the reutilization of the vacated land was received by the City within the delay and the Demolition Committee, on March 21st, 2019, rendered a decision approving said programme for the reutilization of the vacated land;

WHEREAS for the purpose of analyzing the programme for the reutilization of the vacated land, the City has received all the documents required by article 15 of the Demolition By-law PC-2818 and made available to citizens the documents allowing them to grasp the scope of the project;

WHEREAS five hundred and fifty-four (554) appeals of the Demolition Committee's decision approving the programme for the reutilization of the vacated land rendered on March 21st, 2019, were lodged in due time;

WHEREAS the programme for the reutilization of the vacated land subject to present appeal was examined in accordance with the by-laws in force at the time of its filing with the City, namely, January 23rd, 2019;

WHEREAS the appeal documents received by the City reveal various concerns of the citizens for which the City Planning Department carried out additional verifications and, under the circumstances, is able to confirm the conformity of the project with the municipal by-laws, including the space provided for the loading and unloading of delivery vehicles and the height of the building;

WHEREAS it is up to the Demolition Committee and Council sitting on appeal to judge the credibility and probative force of the various reports submitted to them;

WHEREAS Council sitting on appeal of a decision of the Demolition Committee must approve or reject a programme for the reutilization of the vacated land on the basis of the criteria and objectives of the Demolition By-law PC-2818;

WHEREAS any application for a construction permit for the immovable located at 286 Bord-du-Lac–Lakeshore Road will subsequently have to be approved by Council in virtue of the *Village Code and of the SPAIP By-law number PC-2787*;

TO confirm the decision of the Demolition Committee of March 21st, 2019, to approve the programme for the reutilization of the vacated land of the immovable located at 286 Bord-du-Lac–Lakeshore Road;

THAT the programme for the reutilization of the vacated land as approved, be submitted to the Planning Advisory Committee, which will proceed with an analysis in virtue of the criteria and objectives of the Village Code and of the SPAIP By-law number PC-2787 and make its recommendations to Council.
