FOR THE ACQUISITION BY THE CITY OF LOTS 2 528 117, 6 256 023 AND 6 256 022 OF THE QUÉBEC CADASTER, REGISTRATION DIVISION OF MONTRÉAL, OWNED BY "QUORUM LAKESHORE INC." AND LOCATED AT THE NORTH-WEST OF BORD-DU-LAC—LAKESHORE ROAD AND CARTIER AVENUE INTERSECTION, IN POINTE-CLAIRE

RESOLVED:

TO approve and authorize the signature of a transaction to intervene with "Quorum Lakeshore inc." for the acquisition by the City of lots 2 528 117, 6 256 023 and 6 256 022 of the Québec cadaster, registration division of Montréal, owned by "Quorum Lakeshore inc." and located at the North-West of Du Bord-du-Lac–Lakeshore Road and Cartier Avenue intersection, in Pointe-Claire;

THAT the transaction will be done at the price of \$3,750,000, plus the fees and the registration fees, all taxes and other applicable fees;

THAT the Treasurer of the City will be authorized to draw the required funds for the transaction, from the reserves and surpluses available and not otherwise affected;

TO authorize the Mayor as well as the City Clerk and Director of Legal Services to sign for and on behalf of the City of Pointe-Claire, the transaction to be made with "Quorum Lakeshore inc." and all subsequent legal and contractual documents required for the purposes hereof.
