In order to finance the balance of \$500,000 of the expenditure authorized under this by-law, Council is authorized to use a part of the sums not otherwise affected obtained by means of by-law By-law PC-2765 entitled By-law decreeing a long term loan and an expense of \$11,415,000 for road works, aqueduct and sewer works, works pertaining to the renovation of buildings and works for the laying out of various sport surfaces and the stabilization of the river banks, duly approved."
