A deposit is required to ensure repair or replacement of damaged municipal infrastructure as well as to ensure the completion of work and the reception of required documents prepared by professionals. This deposit is required when the permit or certificate is issued and will be returned if there is no damage, if the work is completed and if all the required documents are submitted.
3. If the project is subject to By-law PC-2787 with regards to SPAIP, an additional financial guarantee will be applicable.
4. See By-law PC-2818 for additional financial guarantees applicable for a demolition project.
