

MINUTES OF THE REGULAR MEETING OF THE COUNCIL OF THE CITY OF POINTE-CLAIRE, HELD AT CITY HALL, 451 SAINT-JEAN BOULEVARD, POINTE-CLAIRE, QUEBEC, ON <u>TUESDAY FEBRUARY 9, 2021</u>, AT 4:00 P.M., AFTER DUE NOTICE WAS TRANSMITTED ON FRIDAY FEBRUARY 5, 2021.

PRESENT:

Mayor Belvedere welcomes all the citizens to this regular Council meeting. This meeting is exceptionally being held at 4:00 p.m. due to the curfew in place and this meeting is being held without the presence of the public, in accordance with the maximum alert declared by the Québec government to limit the spread of COVID-19.

In accordance with the rules decreed by the governments, there are only three persons present in the Council Chamber. Mayor Belvedere is accompanied by the City Manager, Mr. Robert F. Weemaes and by the City Clerk, Me Caroline Thibault.

All members of the municipal council participate in the meeting by videoconference from their residences.

ADHESION – COMMITMENT DECLARATION HAVING FOR THEME "LA DÉMOCRATIE DANS LE RESPECT, PAR RESPECT POUR LA DÉMOCRATIE"

WHEREAS the polarization of public opinion in traditional media, and particularly in social media, leads to an increase in aggressive statements and acts of intimidation towards elected municipal officials;

WHEREAS this phenomenon has escalated since the beginning of the COVID-19 crisis in 2020:

WHEREAS intimidation, threats and verbal violence have no place in a democracy and in no way promote the trust and recognition that the population has in its democratic institutions;

WHEREAS respect is a fundamental element of a democratic society which in turn requires the fundamental recognition of great freedoms including, including the freedom of expression;

WHEREAS freedom of expression is fundamental in a democratic society, and that, in respect of the person and the right of all to have and express their opinions;

WHEREAS in accordance with their collective mandate, the elected officials render decisions, make choices and propose recommendations on behalf of all;

WHEREAS a respectful democracy honors the role of elected officials and reinforces the quality and the authority of institutions;

WHEREAS a respectful democracy is founded on mutual respect between those who govern and those who are governed;

WHEREAS the *Union des municipalités du Québec* (UMQ) has launched a national campaign on democracy and respect;

WHEREAS the members of the *Union des municipalités du Québec* (UMQ) board of directors adopted the following commitment statement on December 4, 2020:

"[TRANSLATION] Our democracy is rooted in our history. We choose those who govern us. In a democracy, we can all run for public office. When elections are held, citizens delegate the administration of the common good to people who offer their services, like us. This way of managing our living environments, our regions, has enabled us to achieve one of the highest living standards in the world, to live in security, to have the opportunity to lead our lives as we see fit, and to express ourselves freely.

Democracy comes alive in debate and in the clash of ideas. It is possible as long as people respect each other. But these days, our democracy is too often consumed by unfortunate incidents: rudeness, disrespect, threats, intimidation and impersonation. In recent years, particularly with the rise in popularity of social media, lively but respectful debate has too often been replaced by insults, threats and intimidation.

This was true before the pandemic. But the pandemic has exacerbated this issue. It is normal for this difficult situation to be a source of worry and anxiety. It is normal for us to sometimes disagree with the decisions of the authorities. But it is not acceptable that women and men who have a public responsibility to serve their fellow citizens should be intimidated, forced to resign, sometimes even threatened with death, or forced to travel with police protection.

In less than a year's time, municipal elections will be held in every municipality in Québec. Until then, we have to take care of our democracy. We have to return to a spirit of debate that respects people and institutions so that together we can make the best decisions. Let's remember that elected officials and public office holders are committed to the well-being of their constituents. Let's encourage political involvement, not discourage it.

As elected municipal officials, we are proud to serve our fellow citizens. This is why we are calling for respectful democratic debate. We are saying: democracy with respect, out of respect for democracy. And we invite elected officials in all Québec municipalities to join the movement."

APPEAL – DECISION OF THE DEMOLITION COMMITTEE RENDERED ON DECEMBER 16, 2020, CONCERNING THE IMMOVABLE SITUATED AT 99 CEDAR AVENUE

CONSIDERING the decision of the Demolition Committee (the "Committee") of December 16, 2020 authorizing the demolition of the building situated at 99 Cedar Avenue and refusing the programme for the reutilization of the vacated land;

CONSIDERING an appeal was lodged against this decision;

CONSIDERING THAT Council sitting in appeal may render any decision that the Committee should have rendered, in conformity with provincial legislation and municipal by-laws;

CONSIDERING THAT Council must analyze the impacts of the integration of a new building on the environment into which the project will be inserted;

CONSIDERING THAT Council may, when its discretionary power is applicable, impose conditions it judges appropriate to the decisions it renders, taking into account the specific context of the files.

It is moved by Councillor Stork, Seconded by Councillor Webb, and unanimously

RESOLVED:

TO CONFIRM in part the decision rendered by the Committee on December 16, 2020 regarding the authorization of the demolition of the building;

TO OVERTURN in part the decision of the Committee of December 16, 2020, concerning the refusal of the programme for the reutilization of the vacated land;

Consequently, TO APPROVE the programme for the reutilization of the vacated land presented to the Committee, with the following conditions:

- That a geo-referenced inventory of trees be carried out on the entire property, a particular attention should be paid to trees located in the following sensitive zones:
 - The South slope side of the immovable;
 - The embankments (berms) to the Northeast and East of the house to be built.
- That a forestry report be carried out by a forestry engineer describing the characteristics (species, trunk diameter) and the condition (physiological and/or structural conditions) of the trees affected by the different components of the proposed programme for the reutilization of the vacated land;
- That the applicant demonstrate, to the satisfaction of the City, that the proposed development and construction works (retention wall, drainage network, topographic profile and landscaping plan) take into account and consideration forestry data collected and that the plans submitted allow for optimizing the conservation of the trees and of the canopy on the entire property;
- That the applicant undertakes to plant at least 12 trees as compensation for the mature trees that will necessarily be felled during the works related to the construction of the residence and the development of the driveway;
- That the applicant undertakes to install a plant screen at the southern limits of his/her land to permit the creation of a zone of privacy with the adjacent immovable;
- That the applicant undertakes to implement the technical recommendations made by the Public Works Department regarding the characteristics of the trees to be planted (species, diameter) including those part of the plant screen, as well as the methods and protection and conservation strategy to be implemented;
- That the applicant undertakes to submit plans detailing the site drainage and to implement all technical recommendations made by the Engineering Division of the Territory Management Department of the City;
- That the abovementioned conditions must be met prior to the issuance of all construction permits and all authorization certificates related to the implementation of the programme for the reutilization of the vacated land which must comply in all respects with municipal by-laws in force.

It is understood that the applicant will be deemed to have failed to comply with Section 12 of the By-law respecting the Demolition/Deconstruction of Immovables if he/she does not comply with the abovementioned conditions, and this, to the full satisfaction of the City within a delay of six (6) months of these presents. In such a case, the authorization to demolish contained in the decision of the Committee of December 16, 2020 will be deemed null and void.
