The sale by public auction will take place by videoconference via the Zoom application on Thursday, June 17, 2021, at 9 a.m., in accordance with sections 511 and following of the Cities and Towns Act (R.S.Q, chapter C-19) and the ministerial order 2021-009 published on February 25, 2021.

To participate, each participant must, by noon on June 11, 2021, complete this **form** and return it along with a **deposit of \$1,000** in one of the following ways:

- By registered mail along with a certified cheque or money order (to the order of “Ville de Pointe-Claire” sent to VILLE DE POINTE-CLAIRE – FINANCES, 451 BOUL. SAINT-JEAN, POINTE-CLAIRE (QUÉBEC) H9R 3J3
- In person at the City Hall tax counter (by certified cheque or money order to the order of “Ville de Pointe-Claire”, debit or cash)

In addition, for the purposes of the attestation required under the Civil Code of Quebec, every participant must submit a **proof of identity** (driver’s licence, health insurance card, Canadian passport, or any other official document bearing a photograph).

If the participant is acting on behalf of an individual, he or she must also submit the **power of attorney** signed by his or her principal. **Otherwise, the participant submitting an offer at the sale of immovables will be considered as acting on his or her own behalf.**

If the participant is representing a corporation, he or she must submit a **certified copy of the resolution or the by-law adopted** by the board of directors of the corporation designating him or her as agent.

All deposits other than that of the declared purchaser shall be refunded. the declared purchaser is given a period of two hours after the sale to appear at Pointe-Claire City Hall and pay the balance of his or her bid by certified cheque or money order to the order of “Ville de Pointe-Claire”, or by cash.

Each participant will receive an e-mail at the beginning of the week of June 13, 2021, with the meeting ID code and password for the Zoom meeting on June 17, 2021.

It is your responsibility to install the ZOOM application and ensure that it works.

You will be able to join the ZOOM meeting as of 8:30 a.m. on Thursday, June 17, 2021.
