

MINUTES OF THE REGULAR MEETING OF THE COUNCIL OF THE CITY OF POINTE-CLAIRE, HELD AT CITY HALL, 451 SAINT-JEAN BOULEVARD, POINTE-CLAIRE, QUEBEC, ON <u>TUESDAY APRIL 6, 2021</u>, AT 4:00 P.M., AFTER DUE NOTICE WAS TRANSMITTED ON THURSDAY APRIL 1, 2021.

WHEREAS, in accordance with the following borrowing by-laws and for the amounts indicated with respect to each of them, the City of Pointe Claire wishes to issue a series of bonds, that is, one bond per maturity, for a total amount of \$ 25,000,000 which will be realized on April 19, 2021, distributed as follows:

WHEREAS, in accordance with the 1st paragraph of Section 2 of the Act respecting Municipal Debts and Loans (RLRQ, chapter D 7), for the purposes of this bond issue and for borrowing by-laws numbers PC-2776, PC-2778, PC-2801, PC-2812, PC-2822, PC-2876, PC-2913 and PC-2915, the City of Pointe Claire wishes to issue for a term shorter than that originally set in these by-laws;

- 2. Interest shall be payable semi-annually on April 19 and October 19 of each year;
- 3. The bonds will not be redeemable in advance; however, they may be redeemed with the consent of the holders in accordance with the Act respecting Municipal Debts and Loans (RLRQ, chapter D 7);
- 4. The bonds will be registered in the name of Service de dépôt et de compensation CDS inc. (CDS) and will be deposited with the CDS;
- CDS will act on behalf of its participants as the book-entry agent, bondholder, paying agent and responsible for transactions with respect to its participants, as described in the signed Memorandum of Understanding between the Affaires municipales du Québec and CDS;
- 6. CDS will proceed with the transfer of funds in accordance with the legal requirements of the obligation, to this end, the Council authorizes the Secretary-Treasurer or Treasurer to sign the document required by the Canadian banking system entitled "Autorisation pour le plan de débits préautorisés destiné aux entreprises";
- 7. CDS will make payments of principal and interest to participants by electronic transfers of funds and, for this purpose, CDS will directly withdraw the required amounts from the following account:

8. THAT the bonds be signed by the mayor and the secretary-treasurer or treasurer. The City of Pointe Claire, as permitted by law, has mandated CDS to act as an authenticating financial agent and the obligations will come into force only when they have been authenticated.

AUTHORIZATION – REQUEST FOR INTERVENTION FROM THE MINISTER OF CULTURE AND COMMUNICATIONS OF QUÉBEC TO ENSURE THE PRESERVATION AND RESTORATION OF THE POINTE-CLAIRE WINDMILL

WHEREAS the Pointe-Claire windmill, whose construction dates back to 1710 and which is located on Pointe-Claire's historic tip on the shores of Lake Saint-Louis, has an important place in the history of the City of Pointe-Claire and also the Island of Montréal;

WHEREAS this windmill is the official historical emblem of the City of Pointe-Claire and is also subject to and, in principle, protected by very strict government heritage protection obligations;

WHEREAS this windmill, while the property of the Catholic Church, has seen regular changes in the religious authorities directly responsible for it, in line with the evolution and changes in the Catholic religious communities and authorities who were successively present and assumed responsibility for this site, including the windmill and the neighbouring building of the old convent;

WHEREAS the windmill has seriously lacked maintenance in recent years, and the damage caused by time and weather is increasingly visible;

WHEREAS since 2014, the City of Pointe-Claire has repeatedly undertaken steps, negotiations and offers with the Catholic Church to become the owner of the windmill, either by direct purchase or by long-term emphyteutic lease, and more recently, by usufruct agreement for a period of 99 years, to promote the protection, restoration and enhancement of the windmill;

WHEREAS in the negotiations between the City of Pointe-Claire and the Archdiocese of Montreal, the representatives of the Archdiocese have regularly reiterated their favourable response to and interest in the effective transfer of responsibility for the windmill to the City of Pointe-Claire:

WHEREAS, notwithstanding this seemingly favourable will of the Archdiocese of Montreal, the City of Pointe-Claire is constantly faced with repeated changes in the religious authorities in charge, and especially, in the representatives with the authority required to conclude such negotiations, which has the effect of paralyzing negotiations;

WHEREAS during these endless delays, the condition of the windmill continues to deteriorate and, as more time goes by, the work will become more complex and costly;

TO confirm that the City of Pointe-Claire still wishes to acquire and/or take control of the windmill dating back to 1710 located on Pointe-Claire's historic tip, on the shores of Lake

Saint-Louis and immediately neighbouring the building of the old convent, in order to promote its protection, restoration and enhancement;

TO request that the Minister of Culture and Communications of Québec intervene with the Archdiocese of Montreal for the prompt resumption and, above all, swift and favourable conclusion of the negotiations underway since 2014 to ensure the preservation and restoration of the Pointe-Claire windmill;
