- 5. CDS will act on behalf of its participants as the book-entry agent, bondholder, paying agent and responsible for transactions with respect to its participants;
- 6. CDS will proceed with the transfer of funds in accordance with the legal requirements of the obligation, to this end, the Council authorizes the Secretary-Treasurer or Treasurer to sign the document required by the Canadian banking system entitled "Autorisation pour le plan de débits préautorisés destiné aux entreprises";
- 7. CDS will make payments of principal and interest to participants by electronic transfers of funds and, for this purpose, CDS will directly withdraw the required amounts from the following account:
