
To the persons interested in the draft by-law PC-2775-68-PD1 amending Zoning By-law PC-2775 in order to create a new zone as Pa18 within the territory of the zone Re27 in order to authorize uses under the responsibility of a public body:

NOTICE is hereby given by the undersigned, Danielle Gutierrez, Assistant City Clerk for the City of Pointe-Claire, as follows:

1. On January 18, 2022, Municipal Council adopted the first draft by-law PC-2775-68-PD1, entitled "By-law amending Zoning By-Law PC-2775 of the City of Pointe-Claire in order to create a new zone as Pa18 within the territory of the zone Re27 in order to authorize uses under the responsibility of a public body".
2. The public consultation meeting must be replaced by a written consultation for a period of 15 days from the publication of the present notice. Consequently, any person may submit their comments regarding this draft by-law in writing to the attention of the Legal Affairs and City Clerk Department (451 Saint-Jean Boulevard, Pointe-Claire, Quebec H9R 3J3) or to the following e-mail address: [greffe@pointe-claire.ca](mailto:greffe@pointe-claire.ca), no later than February 25, 2022 at 4:30 p.m.
3. The purpose of this amendment to By-law PC-2775 is to create a new zone within the territory of zone Re27 and to specify the permitted uses and the provisions applicable to this new zone.
4. The provisions of this draft by-law related to uses and zone limits are subject to the referendum approval process.

The [draft by-law](#) and the illustration of the concerned zone and of the contiguous zones may be consulted, by appointment, at the office of the Legal Affairs and City Clerk Department, located at Pointe-Claire City Hall, 451 St-Jean Boulevard, from Monday to Friday from 8:30 am until noon and from 1:00 p.m. until 4:30 p.m. with the exception of holidays as well as on the City portal at [www.pointe-claire.ca](http://www.pointe-claire.ca).

The summary description of the concerned zones is hereinafter indicated:
