WHEREAS one of the amendments concerns Section 29.1 of the Charter of the French language, which stipulates that *Office québécois de la langue française (OQLF)* must recognize a municipality, at its request, when more than half of the residents of its territory have English as their mother tongue;

WHEREAS the City of Pointe-Claire is recognized as having bilingual status since 2005;

WHEREAS the statistics in the 2016 Census confirm that 51% of Pointe-Claire citizens have English as their mother tongue;

WHEREAS the statistics recently published in the 2021 Census confirm that 47.3% of Pointe-Claire citizens have English as their mother tongue;

WHEREAS, when the OQLF observes, in light of the linguistic data from each census carried out in accordance with Canadian legislation on statistics, that a municipality recognized under Section 29.1 does not meet the condition provided for, it must send it a written notice of this finding;

WHEREAS the recognition obtained by the municipality is removed from it, solely by operation of law, at the end of a period of 120 days from receipt of the notice sent by the Office. Recognition is however maintained if the municipality adopts, before this deadline, a resolution for this purpose; it then shall immediately notify the Office;

WHEREAS the City of Pointe-Claire is proactive, and, that at the time of adopting this resolution, no notice from the OQLF informing it of the withdrawal of its recognition as a bilingual city had been received;

WHEREAS the bilingual status of the City of Pointe-Claire is one of the foundations of its community, and contributes to the wealth, culture and social life of its people;

WHEREAS the bilingual status of the City of Pointe-Claire is part of the vision of the City Council and the administration to be an ever more inclusive community;

WHEREAS it is essential for the City of Pointe-Claire to continue to offer services in both French and English to ensure quality and to facilitate exchanges.

REQUEST TO THE FEDERAL GOVERNMENT TO RECOGNIZE THE ECOLOGICAL VALUE AND BIODIVERSITY OF THE LANDS THEY OWN COMMONLY KNOWN AS GOLF DORVAL, INCLUDING THE MONARCHS' FIELD

WHEREAS north of the Montreal-Pierre Elliott Trudeau International Airport is a valuable 215 hectare integrated wetland ecosystem of fields, forests and marshes owned by the Government of Canada and leased to Aéroport de Montréal (ADM) ("federal lands"), partially located in the City of Dorval and the Borough of Saint-Laurent of the City of Montréal.

WHEREAS a large portion of these lands are part of the public space zone (P) in the zoning by-law RCM-60A-2015 of the City of Dorval and the green space used as a golf course, which is 95 hectares in size, is also used for winter activities and other four-season public and recreational uses;

WHEREAS this integrated wetland ecosystem includes the ecologically important Monarch Field, used by Monarch butterflies to feed and breed during their migration to and from Montréal, a city with Monarch Friendly City Gold Level status;

WHEREAS the Monarch Field has been severely damaged in recent weeks, and the entire 215-hectare ecosystem is itself threatened with fragmentation and eventual destruction;

WHEREAS more than 200 species of birds have been identified on the above federal lands, as well as a large number of other animals that make these 215 hectares a center of biodiversity;

WHEREAS the population of the Monarch butterfly has declined by 90% over the past two decades, even though it is an essential pollinator for maintaining biodiversity and a key species for protecting the habitats of many other species that cohabit with the Monarch;

WHEREAS one of the main causes of the decline of monarch butterflies is climate change as it accelerates the eradication of milkweed, the only source of food for caterpillars and therefore essential to the reproduction of the monarch butterfly;

WHEREAS since 2003 and under the Species at Risk Act, the federal government has listed the monarch butterfly as a "species of special concern" and the Committee on the Status of Endangered Wildlife in Canada recommended in 2016 that the government list it as "endangered";

WHEREAS on July 21, 2022, the International Union for Conservation of Nature added migratory monarch butterflies to its "red list" of threatened species;

WHEREAS according to an article in Le Devoir on July 14, 2022, Environment and Climate Change Canada (ECCC) has completed consultations regarding the proposed change in status for Monarch butterflies and a decision is expected by the spring of 2023;

WHEREAS listing Monarch butterflies as "endangered", or at least "threatened", would allow the federal government to take action to protect the critical habitat of this species under section 58 (1) of the Species at Risk Act;

WHEREAS several media outlets reported in July 2022 that Aéroports de Montréal (ADM), which leases the "Champ des Monarques" land from Transport Canada, had recently mowed thousands of milkweed plants without authorization; whereas ADM has denied the presence of any significant amount of milkweed plants on this land; whereas ECCC has opened a "file" to investigate the mowing of the "Champ des Monarques" after being notified by Technoparc Oiseaux; and Technoparc Oiseaux recently issued a press release stating that thousands of milkweed plants have regrown;

WHEREAS more than 34,000 people have signed the online citizen petition, "Un écosystème essentiel aux monarques à restaurer et protéger près de l'aéroport de Mtl", and that this petition is addressed to Steven Guilbeault, Minister of the Environment and Climate Change, to Omar Alghabra, Minister of Transport of Canada and to Philippe Rainville, President and CEO of ADM;

WHEREAS the Communauté métropolitaine de Montréal (CMM) is also involved in the protection of natural environments and adopted an interim control by-law on April 28, 2022 concerning natural environments and a total of 22.3% of the Greater Montréal territory is now subject to conservation measures;

WHEREAS the cities of the Island of Montréal are working together to make up for the deficit of protected natural spaces compared to other Canadian cities, and this last large marshy and river ecosystem, composed of 215 hectares of rare wildlife habitats, is the size of Mount Royal Park;

WHEREAS in December 2021 the Minister of the Environment and Climate Change was mandated by the Prime Minister of Canada to ensure that all Canadians have access to green space, and in particular to create at least one new national urban park in each province and territory, with a target of 15 new urban parks by 2030;

WHEREAS, the 215-hectare federal lands are the last of their kind to exist on the Island of Montreal and therefore form part of the natural heritage that deserves to be protected for all residents of the Island of Montréal;

THAT the Government of Canada recognize the ecological and biodiversity value of the lands owned by the federal government ("federal lands") north of the Montreal-Pierre Elliott Trudeau International Airport, namely lots 3, 4 and 5 located in the borough of Saint-Laurent in the City of Montreal, as well as the lands commonly known as Golf Dorval, including the Monarchs' Field, located in the City of Dorval, all of which are leased to Aéroport de Montréal (ADM);

THAT the Government of Canada, through Transport Canada, notify and require ADM to immediately cease all development on these lands;

THAT the Government of Canada, in keeping with its stated objective of creating or contributing to the creation of an urban park in Québec by 2030, ensure the preservation and conservation of these federal lands in perpetuity for future generations;

THAT the Government of Canada work with the City of Dorval and the Borough of Saint-Laurent of the City of Montréal to secure these lands as a legacy for future generations and as an important part of the urban park system on the Island of Montréal;

THAT this resolution be forwarded to the Federal Minister of Transport, Omar Alghabara, the Federal Minister of the Environment, Steven Guilbeault, all federal Members of Parliament representing ridings on the Island of Montreal, and all elected mayors and councillors in all cities of the Montréal Agglomeration.
