WHEREAS a notice of motion was given and a draft of this by-law was filed on November 8, 2022.

CONSEQUENTLY, MUNICIPAL COUNCIL DECREES AS FOLLOWS:

- 1. By-law PC-1495 Concerning Nuisances ("By-law 1495") is amended by replacing, wherever the terms "City Engineer" or "Director of the Parks and Recreation Department" appear, by the term "Director or Assistant Director of the City's Inspection Public Security Department".
- 2. Paragraph a) of Section 1 of By-law 1495 is amended by becoming Section AA and shall consequently precede Section 1.
- 3. Paragraph a.1) of Section 1 of By-law 1495 is amended by inserting the word "tolerate" after the word "allow".
- 4. Paragraph a.3) of Section 1 of By-law 1495 is amended by inserting the word "tolerate" after the word "allow".
- 5. Paragraph a.4) of Section 1 of By-law 1495 is amended by inserting the word "tolerate" after the word "allow".
- 6. Paragraph a.5) of Section 1 of By-law 1495 is amended by inserting the word "tolerating" after the word "permitting".
- 7. Paragraph b.7) of Section 1 of By-law 1495 is amended by inserting, after subparagraph 8°, the following subparagraph:
 - '9° Use of a generator during a power outage or service interruption planned by Hydro-Québec or when carrying out required testing or repair work on said device, and in the latter case, only between 7:00 am and 9:00 pm."
- 8. Section 4 of By-law 1495 is amended by replacing the words "special tax thereon" by the words "property tax thereon if the debtor is the owner of the immovable, or otherwise, in the same manner as a non-property tax.
- 9. Paragraph c) of Section 4.5 of By-law 1495 is replaced by the following text:
 - "c) City authorized representative": any member of the Montreal Police Department as well as any officer or employee of the City's Inspection-Pubic Security Department".

10. The present by-law will come into force according to the law.
