

# 2024 Pre-budget consultation

The <u>Commission sur les finances et l'administration</u> (committee) would like to consult Montrealers on the city's budget directions for 2024.

The 2024 pre-budget consultation is a mechanism of participatory democracy which provides you with an opportunity to share your ideas and opinions to inform the development of the next budget. This year, Montrealers are invited to give their input on new ecofiscal and fiscal measures, as well as on a review of activities and programs offered by the city and the Montréal urban agglomeration.

## Step 1 - Obtain information

The consultation document will be presented during a **public information session**.
