Interested in this topic? Take part in the debate to develop a functional and regulatory framework based on the harmonious cohabitation of night-time activities, for the benefit of all.

Step 1 – Obtain information

Montréal's nightlife policy draft will be presented during a public information session.

Date and time:	Tuesday, February 13, 2024, at 6 p.m.
Place:	Council chamber, city hall (Lucien-Saulnier building) 155, rue Notre-Dame Est, Montréal
Livestream:	The public session will be livestreamed and archived at ville.montreal.qc.ca/politique-vie-nocturne

The presentation will be followed by a question period. To take part in the question period, register using the <u>online form</u> (in French) or on site, as of 5:30 p.m.

Step 2 – Share your views: various ways to give your input

You can share your views on the subject of the consultation in the following ways:

1- Present an opinion to the committee during the public hearings scheduled on:

Monday, March 11, 2024, from 1:30 p.m. - By videoconference

Thursday, March 14, 2024, from 7 p.m. – In person Council chamber, city hall, 155 rue Notre-Dame Est

Friday, March 22, 2024, from 1:30 p.m. – In person Council chamber, city hall, 155 rue Notre-Dame Est

Step 3 – Attend the public session for the adoption of the recommendations

The committee will publicly present and adopt its recommendations at a **livestreamed public meeting.**

The draft recommendations and the form for submitting a question or a comment will be available the day of the meeting on the same website.
